1. \$ 100.00 FEE MADE PAYABLE TO: B C COMMUNITY MANAGEMENT
2. LEASEE **MUST** MEET PERSONALLY WITH HOA BEFORE MOVING IN - CONTACT ABOVE
3. LEASE AGREEMENT SIGNED BY ALL PARTIES
4. BACKGROUND CHECK MUST BE DONE ON ALL TENANTS – ALSO MUST BE DONE ON ALL RENEWAL LEASES
5. **COPY OF PROOF OF AGE MUST BE PRESENTED. (DRIVERS LICENSE, BIRTH CERTIFICATE, MILITARY ID)**
6. AT LEAST ONE (1) RESIDENT IS AT THE AGE OF FIFTY-FIVE (55) YEARS OR OVER AND MUST OCCUPY THE RESIDENCE DURING THE TERM OF THE LEASE. NO INDIVIDUAL UNDER THE AGE OF 22 CAN RESIDE IN A UNIT.
7. ALL DOCUMENTS MUST BE SUBMITTED TWO WEEKS BEFORE THE TENANT MOVES INTO THE UNIT. INCLUDING RENEWALS. IF DOCUMENTS ARE NOT SUBMITTED WITHIN TWO WEEKS NEW TENANTS AND RENEWALS MUST WAIT ONE WEEK FOR CREDIITIALS UPON APPROVAL. IF LEASE IS NOT APPROVED TENANT WILL NOT RECEIVE CREDENTIALS AND COULD POSSIBLITY FACE EVICTION. RENEWALS COULD FACE ACCESS CARD AND GATE ACCESS BEING SHUT OFF AND POSSIBLE EVICTION.
